

# 2008-2009 BLANKET BONDING

## Class A - No Deductible

Blanket bonding is being provided to Posts and Districts that would like to bond officers other than the Post Quartermaster. VFW National and VFW Department By-Laws require that each accountable officer be bonded with an indemnity company as surety in a sum at least equal to the amount of liquid assets for which, as far as can be anticipated, each officer may be accountable. To provide this coverage, arrangements have been made with CNA Surety Company to provide a blanket type bond to cover five (5) positions. Each position is covered in the amount of \$10,000 to limit requested. Costs for the bond are listed on the next page.

**The five (5) positions covered, unless otherwise specified:**

**Commander - Quartermaster - Assistant Quartermaster - Bingo Chairman - Canteen Manager**

**SUBSTITUTIONS::**

CNA Surety Company has agreed to allow substitutions for Posts which may not have one of the five (5) positions listed above. All substitutions must be VFW members. Examples of positions that may be covered are: Buddy Poppy Chairman, Adjutant, etc. Substitutions require prior approval.

**REMEMBER:**

Only 5 positions can be covered. If substitution is used, strike-out the uncovered position.
